1. With reference to your online application against DIAT Admission Notice- July 2017, you are provisionally shortlisted for counselling-cum-admission to M.Tech in **Technology Management** in the Department of Technology Management. List of selected and wait list candidates will be uploaded at our website.

2. You are requested to report to **Defence Institute of Advanced Technology, Girinagar, Pune-25** alongwith the following documents in original & 1 set of self certified photocopies, and prescribed amount at **9.00 AM on 01 June 2017** for the counselling-cum-admission process.

- A print out of the online application
- Proof of date of birth
- Certificates in proof of educational qualifications
- SC/ST/OBC [with Non-Creamy layer certificate] / PH / KM certificate issued by the competent Govt. authority, if applicable.
- GATE Score card.
- Part payment of fee Rs. 16000/-

Note:- counselling-cum-admission will be conducted on the scheduled date & time. However you are advised to come prepared for an overnight stay so that if the counselling-cum-admission extends to the next day, you will not be having any difficulty

3. Your admission for counselling-cum-admission is provisional and will be subject to verification of your certificates and other testimonials. **In the absence of non-production of any of the above mentioned documents/testimonials at the time of verification, you will not be allowed to take admission.**

4. **If selected during counselling-cum-admission process, you shall have to confirm acceptance of offer of admission by depositing part payment of fee Rupees 16,000/- by cash/payment through State Bank Collect (www.onlinesbi.com/preloqin/collecthome.htm) on the same/ immediate next day at cash section, DIAT, failing which your seat will be offered to the next candidate in the waiting list. No representation will be entertained thereafter.**

5. The date of registration for program will be **27th June 2017 to 30th June 2017**. The classes for M. Tech program will commence w.e.f. 03 July 2017. You are required to produce the Original Migration Certificate from the University from where you passed out last, within three months from the date of joining the program. OBC candidates are required to produce the validated non-creamy layer certificate.

6. The course Fee is currently Rs. 2,51,000/- (for GEN/OBC candidate) per year and Rs. 2,31,000/- (For SC/ST candidate) (As applicable), per year which is subject to change as per Institute Rules. A caution deposit (refundable) of Rs.10000/- and remaining amount of fee (i.e. Rs. 2,35,000/- (for GEN/OBC candidate) and Rs. 2,15,000/- (For SC/ST candidate)) shall be required to be paid during registration period(i.e. during **27th Jun 2017 to 30th June 2017**). **You will not be eligible for applying for Scholarship under DBT scheme of AICTE, during M. Tech Course. No financial support will be available from DIAT (DU), Pune.**

7. Accommodation and mess facilities are available in the POINTS Hostel on payment basis. However, due to very limited rooms in POINTS Hostel, it may or may not be possible to provide Hostel accommodation to all the students. The present monthly charge towards boarding and lodging is ~Rs.7000/- (subject to revision). A security deposit of Rs. 20,000/- would need to be paid to Hostel office.

8. Your admission and M.Tech studies shall be governed by the Rules and Regulations of the PG Programme of DIAT (DU) and the UGC, AICTE regulations for M.Tech studies, as amended from time to time. You are required to mark attendance through DIAT Biometric attendance system daily.

9. Please note that no TA/DA will be paid for attending the counselling-cum-admission. Request for change of counselling-cum-admission date will not be entertained **under any circumstances.**
