Essential.

- (a) M.Tech / ME with specialization in the area as per table given at Para 3 above, with 55%* marks in Bachelor's and Master's Degree or equivalent Cumulative Grade Point Average (CGPA).
- (b) 01(One) year Teaching Experience.

**A relaxation of 5% (in qualifying marks) will be extended at the Graduate and Masters' level, for candidates belonging to SC/ST/OBC (NCL)/Differently abled category, for the purpose of eligibility.*

Desirable.

- (a) Teaching, research, industrial and/or professional experience in relevant area in a reputed organization;
- (b) Papers presented at conference and/or in referred journals.
- (c) A Ph.D. degree in the relevant area.
